UNDER THIS PROGRAM, KHEYTI HELPS SMALLHOLDER FARMERS BECOME CLIMATE RESILIENT BY PROVIDING THEM ACCESS TO LOW-COST GREENHOUSE TECHNOLOGIES AND GIVING THEM FREE TRAINING, EDUCATION AND LINKAGE SERVICES. THE PROGRAM LAUNCHED IN 2017 AND REACHED 50 FARMERS IN INDIA AT THE END OF THE YEAR. WHILE THE PROGRAM COSTS PRIMARILY INCLUDE MANPOWER COSTS AND PURCHASE OF MATERIAL, SMALL GRANTS WERE GIVEN TO FEW OF THE EARLY FARMERS FOR ENCOURAGEMENT.
